Tuition Payment Information

- A *non-refundable deposit of **\$1,000** is due with the submission of this enrollment agreement. A minimum deposit of 50% of the total balance is due for applicants whose balance is less than \$2,000. *This deposit is applied toward administration fees, registration fees, class supplies, and testing fees associated with the written and practical tests.*
- Remaining balance of tuition is due before the completion of the class attended.
- Tuition may be paid via Credit Card, Cash, Money Order or Company Check. Sorry, we do not accept personal checks.

*Some exceptions to the due date and the refund eligibility of the non-refundable deposit and tuition are made in the certain extenuating circumstances listed below. These exceptions are to be made with the permission of an Authorized Crane Wise Certifications administrative personnel only.

Cancellation/Refund Policy

- Applicants have two options when needing to cancel or reschedule a class they have registered for:
 - **Advance Notice Cancellation:** An applicant who provides at least twelve (12) *business days advance notice in writing, via mail or email, to the scheduled class start date will have two options: 1) Be entitled to a refund of all monies paid minus a \$300 administrative fee; 2) Opt to postpone for a later class date and keep \$1,000 on file as an active credit for one (1) calendar year, with a refund of any additional monies paid. No monies would be forfeited utilizing option 2, as long as the credit is used within 12 months of the date cancellation was provided.
 - **11-Day Cancellation:** An applicant who provides eleven (11) or fewer *business days advance notice in writing, via mail or email, to the scheduled class start date will have two options: 1) Be entitled to a refund of all monies paid minus the \$1,000 deposit; 2) Opt to postpone for a later class date and keep \$700 on file as an active credit for one (1) calendar year, with a refund of any additional monies paid. Due to the late notice, a \$300 administrative fee will be retained.
- **Rejection:** An applicant that is rejected by the school for any reason before attending any scheduled class time is entitled to a full refund of all monies paid to Crane Wise Certifications. The applicant will receive in writing, the reason for the rejection, along with the refund via mail.

No later than thirty (30) business days of receiving written notice of cancellation from the applicant, Crane Wise Certifications shall issue a refund of all monies paid by the applicant minus the administrative fee stated above.

*Business days exclude Saturday, Sunday and/or all federal or state holidays
